

02. The tender should be accompanied with an earnest money equivalent to 2% of the rate quoted in shape of demand draft in favour of the ICAR-Unit, IIWM payable at Bhubaneswar drawn preferably on any nationalized bank which will be refunded to the unsuccessful tenderers within a reasonable time.

03. Tender not accompanied with earnest money will not be entertained.

O4. The successful tenderer will have to deposit 5% of the tender cost as security deposit in shape of demand draft favouring the ICAR-Unit, IIWM, Bhubaneswar drawn preferably on any <u>nationalized</u> Bank which will be retained for DLP for the faithful fulfillment of the contract but shall be forfeited if he fails to do so. The contractor will duly perform the said work mentioned in the work order and shall execute the same with great promptness, care and accuracy in a work man like manner to the satisfaction of the Director, ICAR-IIWM, Bhubaneswar and will complete the same with desired specifications within a period of 45 (forty five) days under the guidance of \_\_\_\_\_\_ who will be the works-in-charge or his nominee. Failing which he will be liable to disciplinary action for compensation of losses if any as per the decisions of the works committee of ICAR-IIWM, Bhubaneswar.
